Today i.e. 04-05-2023 at 7:10 pm. large numbers of mob numbering about 500 to 1000 armed with sophisticated/deadly weapons tried to intrude G.Saparmeina Police station and Police on duty fired several rounds of live ammunitions in the air however the unruly mob overpower the security personnel and started entering inside the PS and broke the Arm Kote and Malkhana. In which they have looted (1) 5 nos. of 9mm Carbine with 6 nos. of mag. and 119 rounds, (2) 1 no. of 9 mm pistol with 5 nos. of mag. and 24 rounds, (3) 10 nos. of AKM Mag., (4) 5 no. of Ex caliber 5.56 mm mag., (5) 1 no. of 5.56 mm INSAS Rifles with 9 nos. of Mag. and 101 rounds, (6) 1 no. of 5.56 mm INSAS LMG with 9 nos. of mag. and 270 rounds, (7) 26 nos. of 7.62 mm SLR with 62 nos. of mag. and 1629 rounds, (8) 10 nos. of 7.62 x 39 mm Ghatak rifle mag., (9) 97 nos. of Rubber bullet, (10) 2 nos. of MK-IV Grenade, (11) 10 nos. of 3-Way Grenade, (12) 2 nos. of 3 way grenade tear smoke, (13) 8 nos. of Tear smoke sharp(long range shell), (14) 7 nos. of stun shell, (15) 17 nos. of Stinger grenade, (16) 7 nos. of tear smoke, (17) 16 nos. of tear smoke shell(soft nose-SR), (18) 16 nos. of tear smoke shell (LR), (19) 50 nos. of 303 mm blank ammunition, (20) 50 nos. of 7.62 blank ammunition, (21) 11 nos. of 303 Rifles with 11 nos. of mag. and 888 rounds, (22) 2 nos. of 38 Revolver with 16 rounds, (23) 5 nos. of BP Jacket heavy weight, (24) 6 nos. of Pudka helmet, (25) 2 nos. of BP Helmet, (26) 6 nos. of mobile morch, (27) 5 nos. of cane shield, (28) 13 nos. of Fibre shield, (29) 3 nos. of Helmet (with fibre), (30) 3 nos. of Fibre lathi, (31) 10 nos. of 12 bore gun (4- nos. of SBBI 12 bore Pump Action Gun, 6 nos. of 12 bore gun DBBI folding) which were deposited by Range Forest Officer, Metbung in the Arm Kote and numerous nos. of arms and ammunitions in the PS Malkhana. The mob also damaged/destroyed both the CCTVs and the CPU with hard disk installed at the P.S.

Hence, a suo-motto case has been registered under FIR No. 26(5)2023 G.SPM PS U/S 353, 449/392/427/34-IPC & 25(1-C) A. Act for investigation
