
Sir,

With due respect, I have the honour to state that, on 18th June, 2023 column of 20 JAT Regt. (Indian Army) deployed to protect Hengjang Village at 2330 hrs, Army No. 3205970Y Naik Jasaveer Singh noticed movement in nallah ahead of his location. The individual challenged the suspected movement. His picquet was fired upon by automatic weapon by the unknown miscreants to which he retaliated and saved the lives of civilians and village from burning, Naik Jasaveer sustained gun shot wound at his left lower limb (Fracture shaft of fabula). Individual was immediately evacuated to 183 MLI Leimakhong Military Station and wherein he was operated for injury at 0200 hrs 19 June, 2023.

In this regard, I request your kind favourable to take up necessary legal action.
