Dear Sir,

As we all are aware regarding the critical situation of Manipur since 3rd May 2023, due to some geo-political and local body's identity issue of community, an unexpected violence is continued in Manipur. Gamphazol and nearby area is very much affected, and curfew (Sec 144) imposed. Our one new 132/33 kv sub stations under construction at Gamphazol and badly affected due to this violence.

Sir, yesterday i.e 21.05.2023 at about 11:30 PM, we got an information regarding some miss happens at our Gamphazol sub-station. Some miscreants people gathered at our 132/33 kv Gamphazol sub-station and damaged the sub-station. They broke some glasses and windows of control room and stole some equipment and furniture's as reported by our security guards. As per security guards they damaged or theft the :-

1. Damage two numbers of CRB Aluminium gate with glass	Value: - 60000 (Approx)
2. Some isolators and S/Y equipment's	Value: - 12000 (Approx)
3. They Stole : 04 no's SAS monitors	Value: - 48000 (Approx)
4. Mouse & Keyboards	Value: - 1200 (Approx)
5. Desktop computer : 01	Value: - 65000 (Approx)
6. Printer : 01	Value: - 55000 (Approx)
7. Inverter : 01	Value: - 210000 (Approx)
8. Chairs : 04	Value: - 33000 (Approx)
9. AC : 02	Value: - 80000 (Approx)


The above items are reported by securities guard, we can't access the site for actual list of damage due to the communication gap as transportation and mail access. They also threat the guards to burn the sub-station. The Total Approx value of the said damaged and taken items is Rs:- 5,64,200.00 (Five Lacs Sixty Four Thousand and Two hundred Only)

Kindly take the necessary action with G. Sapormeina Police Station to make the safety of Gamphazol sub-station.
