Today i.e. 8/3/2024 at 5:40 pm, received an information that on the same day at about 5:30 pm, one motorcycle KTM Duke bearing regd. no. MN06SE3269 which was proceeding from Wangbal towards Wangbal Lamboithong side along IVR Wangbal and ridden by unknown person met an accident at Wangbal Lamboithong near Young Star Development Club with one Tractor Massey Ferguson with trolley bearing regd. no. NIL driven by unknown person which was proceeding in opposite direction due to rash or negligent riding on the part of both rider/driver. As a result of it, unknown rider and two unknown pillion rider of the KTM Duke sustained injuries and the said motorcycle was also badly damaged. The injured persons were evacuated to the District Hospital Thoubal for medical treatment.

Hence, a suo-motu case FIR No. 27(3)2024 TBL-PS U/s 279/338/427 IPC has been registered for investigation.
