Subject- Report.

I have the honour to report that in view of current prevailing law and order situation and to detect any kind of illegal and snatched weapons, incriminating articles concealed and to sanitize the areas properly today i.e. 11/04/2024 at around 4:30 am, under the supervision of Shri Ksh. Ravikumar Singh IPS, Superintendent of Police, Bishnupur District and Shri Amarjit Singh Lamabam, MPS, Addl. SP(OPS)/BPR, a joint cordon and search operation was conducted by a combined teams comprising of District Police Bishnupur led by D. Robinson MPS, CDO-II/BPR assisted by Sub. Y. Shaktishen Singh OC/CDO BPR, Hav. No.132001230 H. Nungshithoi Singh of CDO-BPR, Hav.no.15007648 RK. Manjit Singh of CDO/BPR, a team of PGCI-PS led by Inspt. W. Dhiraj Kumar Singh OC-PGCI-PS and a column of 16" Kumaon Regiment in between Kwakta and Saiton gap near Phougakchao Ikhai Village under PGCI-PS jurisdiction. During the said search operation, a suspicious khaki colour carry bag was observed hidden under a culvert and on tactically checking of the suspicious bag, 4 nos. of containers suspected to be unarmed IED, one country made .32mm pistol along with one magazine loaded with 2 live rounds of .32 ammunitions were found concealed inside the bag. Immediately, the joint combined teams seized the 4 nos. of containers suspected to be unarmed IED, one country made .32mm pistol with along one magazine loaded with 2 live round of .32 ammunitions after all due formalities at 7:30 am of the same day. The search and cordon operation was concluded at 08:00 am. The seized items were brought to PS and handed over to OC/PGCI-PS for further legal action.
