

Subject: Report

Sir,

With due respect, I ASI Isaac Kilong, G.SPM PS deployed as Koubru, Mangjol duty Commander have the honour to report that on dated 03-05-2023, we got threat from the public in connection with the prevailing law and order situation and in the meantime, rescued 5(five) Manipuri workers today i.e. 04-05-2023 who were engaged in construction of Songpijang bridge and dropped till G.SPM PS safely. In view of the prevailing law & order situation, I have request/inform the matter regarding threat received to my superior Officer to withdraw from the post as we are less in number and for security reason that we wouldn't be able to defend ourselves. On the evening at around 9:00 pm, as we have seen large mob around 100-200 approaching towards us in all angles, Police on duty made blank fire several rounds and we have shouted not to come forward however they overpower us and started entering the barrack and collected all the weapons. To save our live, self and teams rushed towards PS and informed the incident to my superior. The mob had also burnt down our barrack along with all bedding and uniforms. The following are the arms and ammunitions looted from us viz-1) 2 nos. of INSAS Rifles with 3 mag. and 60 rounds, (2) 2 nos. of Excalibur with 2 mag. and 35 rounds, (3) 6 nos. of SLR with 6 Mag. and 70 rounds, (4) 8 nos. of 303 rifles with 8 mag. and 80 rounds.

I therefore request you to take necessary action in connection with the incident.
