Sir,

With due respect, I have the honour to state that on the 29<sup>th</sup> June 2023 at around 4:30 pm by the Meitei community Arambai Tenngol, Meitei Leepun and Meitei militant holding deadly weapon including Automatic Rifles attack our village i.e. Bethel Village Kangchup Geljang Sub-Division, Kangpokpi District. They robbed, demolished (destroyed concrete building by using JCB) and burnt down my house along with the following properties and important documents etc. The details are as under:

The Total amount of destroyed properties are estimated at **Rs39,34,000/-** (Rupees thirty nine lakh thirty four thousand) only. The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.
