

Subject: Report for stolen of my cows.

Sir,

With due respect I the undersigned have the honour to state the following few lines for your kind consideration and favourable orders.

That, on 14/04/2024 in the morning at around 6:30 am I kept my 2 (two) cows i.e. mother cow Black in colour tied by rope and a calf red in colour at the southern side of my house located at Phougakchao Ikhai Awang Leikai which is adjacent to Heikon village, inhabited by the Kuki Community for grazing in the field. However, in the evening at around 2:00 pm of the same day, the said 2 (two) cows were found missing. From that moment we started searching along with the security personnel of Kumaon Regiment who were already deployed at the fringed area in connection with the Communal Clash that erupted since 3rd May 2023. Unfortunately, we could not trace out the missing cows till date in spite of hectic efforts made by us. I suspected that my missing cows might have been taken away/stolen by some unknown Kuki people of Heikon area as we are not able to go there and search due to current situation.

It is therefore, requested you sir to kindly look into the matter and book the culprits who involved in that with suitable sections of law.
