

Sir,

With due respect, I have the honour to report that on 05-05-2023 at around 1:30 pm, unknown miscreants numbering about 300 persons from the Meitei community suspected to be Arambai Tengol, Meitei Leepun for Kangleipak Kanba Lup holding deadly weapons entered our village i.e. K.Phaijawl and demolished/burnt down 35 houses along with household goods and properties including 2(two) –two wheelers, three Auto Rickshaws and also robbed the domestic animals in the village. The approximately lost/destroyed is estimated to be about 10 crores approx.

The incident couldn't be reported in time due to insecurity of our lives and the volatile situation of the area.


I, therefore request you to take necessary action against the perpetrators/culprits involved in commission of the crime.
