With due respect, I have the honour to state that on the 29th June 2023 at around 4:30 pm by the Meitei community Arambai Tenngol, Meitei Leepun and Meitei militant holding deadly weapon including Automatic Rifles attack our village i.e. Bethel Village Kangchup Geljang Sub-Division, Kangpokpi District. They robbed, demolished(destroyed concrete building by using JCB) and burnt down my house along with the following properties and important documents etc. The details are as under:
