Sir,

With due respect, I have the honour to state that on the 29<sup>th</sup> June 2023 at around 4:30 pm by the Meitei community Arambai Tenngol, Meitei Leepun and Meitei militant holding deadly weapon including Automatic Rifles attack our village i.e. Bethel Village Kangchup Geljang Sub-Division, Kangpokpi District. They robbed, demolished(destroyed concrete building by using JCB)and burnt down my house along with the following properties and important documents etc. The details are as under:

The Total amount of destroyed properties are estimated at **Rs37,79,000/-** (*Rupees thirty seven lakh seventy nine thousand*) only. The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime. Thanking you Sir.
