With due respect, I have the honour to report that on 05-05-2023 at around 1:40 pm, unknown miscreants numbering about 300 persons from the Meitei community suspected to be Arambai Tengol, Meitei Leepun for Kangleipak KanbaLup holding deadly weapons entered our village i.e. K.Moljol and demolished/burnt down 14 houses along with household goods and properties including 2(two) –two wheelers and also robbed the domestic animals in the village. The approximately lost/destroyed is estimated to be about 8 crores approx.

The incident couldn't be reported in time due to insecurity of our lives and the volatile situation of the area.

I, therefore request you to take necessary action against the perpetrators/culprits involved in commission of the crime.
