With due respect, I have the honour to state few lines before you for your kind consideration and necessary action.

That, on 3rd May 2023 at around 7:00 PM, my son namely Mr. Khaikhosat Kipgen (22) S/O (L) Ngamkhohao Kipgen of Haipi Village, Kangpokpi District was shot by unknown miscreants from Meitei community while he was on a peaceful protest at Gamgiphai area. My son got injury on his left leg and as such, he was immediately evacuated to Kangpokpi Christian Hospital for medical treatment. The doctor after examination had refer him to higher Centre for further evaluation.

I could not report the incident in time as I have attend my son in his further medical treatment outside the state.

I therefore kindly request your good office to kindly take up necessary action in this regard. Thanking You Sir.
