Sir.

With due respect, I have the honour to state that, on the 5<sup>th</sup> June 2023 at around 3:30 PM. Unknown miscreants numbering more than 500 people from Meitei community suspected to be members of Arambai Tengol, Meetei Leepun, Extremist volunteers by holding deadly weapons like Automatic Ritles attacked our village i.e K. Songlung Village under Kangchup Geljang Sub Division, Kangpokpi District. The miscreants have burnt down my house, my chicken farm and all my household properties like Furniture, Kitchen and Utensil items, Clothing and Garments, Electronic items, Rice and Food grains into ashes. The miscreants have also destroyed my four wheeler vehicle.

The approximate amount of my burnt down properties are estimated at Rs. 35.00,000/- (Rs. Thirty five Lakhs only).

The incident could not be reported immediately due to insecurity of our lives and volatile situation in the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime. Thanking you Sir.
