

**SUB: FIRST INFORMATION REPORT**

It is to inform you that on 18<sup>th</sup> March 2023 at about 2345 hrs No.121501413 CT(GD) Kamal Kishor Tirkey of 'B' Coy 42 Bn BSF attempted for suicide by using his own small knife in Jawan barrack and got superficial cut injury on his neck. No.223900095 CT Yuvaraj J. living on same jawan barrack observed that CT Kamal Kishor Tirkey was trying to cut his neck by using small knife but in the mean time said constable stopped CT Kamal Kishor Tirkey and by hearing shouting of CT Yuvaraj J, No.120616930 CT Manoj Saini, No.12067622 CT Parvat Singh, No.130828710 CT Nirmal Mandal and No.171300086 CT Kumar Chandan Yadav also ran to stop CT Kamal Kishor Tirkey. Later on first aid treatment was given by No.018770973 HC/NA Ganesh Chhetri. After that individual was kept under custody by placing guards (Namely No.108090972 CT Rakesh Kumar from 190001 to 190300 hrs and No.110094689 CT Y.A Tulajannavar from 190300 to 190600 hrs. At about 190530 hrs while laying in the bed covering with sleeping bag, No.121501413 CT Kamal Kishor Tirkey scratched his wound by his fingers due to which bleeding started and after seeing such incident No.110094689 CT(GD) Y.A Tulajannavar who was performing his protection guard duty shouted and informed all the troops available in barrack Namely CT Manoj Saini, CT Parvat Singh, CT Nirmal Mandal and CT Kumar Chandan Yadav, etc. After that CT Kamal Kishor Tirkey (Patient) was immediately evacuated to Distrcit Hospital Thoubal alongwith ASI B.Vichat Bhai and 07 ORs (including Nursing Assistant HC Ganesh Chhetri Mob No.9735590965) where doctor did 03 layers stitching of cut wound and further shifted to RIMS hospital, Imphal for better treatment. Presently, the condition of patient is stable.

In the view of above, it is requested to lodge FIR, please.
