On 5th June, 2023, Kangchup Songlung Village, under Kangchup Geljang block, Kangpokpi districti attacked with heavy firing and mortar shelling and burnt down by meiter mob supported by armed meitei militants, Arambai Tenggol.

My Sawm-Inn Layer Poultry Farm with 500 birds giving more than 450 eggs daily was also burnt and destroyed completely. The poultry farm was set up with a total investment of more than 20 lakhs of which 10 lakhs was taken as Mudra loan from Bank of Baroda, RIMS Branch.

I could not report the incident on time as I had to take my family to safer areas and come back to my village and took part in protection of our village.

I request your good office to take necessary action in this regard.
