

Sir,

I have the honour to state that on 04-05-2023 at around 06:40 pm, large mob numbering about 200 (two hundred) suspected to be unknown public of Leimakhong area try to intrude the PS and in the meantime Police personnel on duty fired several rounds of ammunitions in the air however they overpowered and forcefully entered the PS and snatched arms and ammunitions from the police personnel and started breaking locked of the Arm Kote and robbed the following Arms and ammunitions from the

1. 3 (three) nos. of SLR Rifles with 12 mag. and 280 rounds
2. 6 (six) nos. of 303 Rifles with 6 mag. and 300 rounds
3. 6(six) nos. of INSAS Rifles with 12 mag. and 240 rounds
4. 3 (three) nos. AK Rifles with 8 mag. and 240 rounds
5. 2(two) nos. of SMG carbine with 2 mag. and 50 rounds
6. 2(two) nos. of 9 mm Pistol with 3 mag. and 90 rounds
7. 1(one) no. of tear Gas Gun
8. 45(forty five) nos. of Tear Gas ammunitions

So, I therefore request you to kindly take up necessary legal action against the culprits.


