



Sir,

With due respect , I have the honor to report that, on 28-06-2023 at around 8:00 am, group of miscreants suspected to be Arambai Tengol, Meitei Leepun and other extremist volunteers numbering more than 500 people by firing various automatic weapons attacked our village i.e Singda Kuki, Kangchup, Kangpokpi District. In the incident, the miscreants have vandalized my house, looted my household properties and 18 Nos of Pigs and finally burnt down my house and remaining household properties into ashes.

The approximate value of loss properties is estimated to be about Rs.20 lakhs(Twenty lakhs) only.


I, therefore kindly request you to take necessary action in this regard.
