



Sir,

With due respect, I have the honour to report that, on 28-06-2023 at around 11:00 am, group of miscreants suspected to be Arambai Tengol, Meitei Leepun and other extremist volunteers numbering more than 500 people by firing various automatic weapons attacked our village i.e Singda Kuki, Kangchup, Kangpokpi District. In the incident, the miscreants have looted 210 Nos of Gas Cylinders, 50 Nos of Gas Stove, 110 Nos of Hose pipe, 36 Nos of Gas Lighter and 70 Nos of Gas regulator from my store house and finally burnt down my Gas Agency Store/House " M/S S&M BHARTI GAS AGENCY, Trade License No. 1768.

The approximate value of loss properties is estimated to be about Rs.20 lakhs (Twenty lakhs) only.


I, therefore kindly request you to take necessary action in this regard.
