Sir,

With due respect, I have the honour to state that, on 05/05/2023 at around 07: AM while I was on duty at Leilon Vaiphei were 144 CrPC was imposed by District Magistrate Kangpokpi District, Manipur self and team alongwith 8<sup>th</sup> IRB CDO Bn., platoon led by ASI Md. Barik and team deployed for Law and Order duty and stationed at temporary camp located at CC Hall in Leilon Vaiphei. Unexpectedly, large mob numbering of around 150(one hundred and fifty) suspected to be unknown public of Leimakhong area overpowered and forcefully snatched the following Arms and Ammunitions:

1. 2(two) nos of AKM Rifles alongwith 2(two) Magazine and 60(sixty) live rounds of 7.62 X 39MM from Lmk-PS
2. 1(One) 9MM Pistol alongwith 1(one) Magazine and 10(Ten) live rounds from 8<sup>th</sup> IRB CDO
3. 8(Eight) AKM Rifles alongwith 15(fifteen) Magazine and 450(Four hundred fifty) live rounds from 8<sup>th</sup> IRB CDO


