Sir,

With due respect, I have the honour to state on the 2nd June 2023 at around 5:00 PM. unknown miscreants numbering more than 200 people from the Meitei community suspected to be members of Arambai Tenngol, Meitei Leepun and other Extremist volunteers holding deadly weapon including Automatic Rifles attack our village i.e. Nakhujang Village, Kangchup Geljang Sub-Division, Kangpokpi District. They burnt down my house along with the house-hold properties like Electronic items, Kitchen items, Furniture, Clothing and garment, Granary and other items into ashes.

The Total amount of destroyed properties are estimated at Rs 30,00,000/- (Rupees Thirty lakhs only). The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.


