

Sir.

With due respect, I have the honour to state on the 5th June 2023 at around5:00 PM, unknown miscreants numbering more than 200 people from the Meitei community suspected to be members of ArambaiTenngol, Meitei Leepun and other Extremist volunteers holding deadly weapon including Automatic Rifles attack our village i.e. K Songlung Village, Kangchup Geljang Sub-Division, Kangpokpi District. In the incident, the miscreants have burnt down my Pigsty along with 10 (ten) nos of Pigs which I reared it after obtaining Piggery Loan from SBI, Kangchup Geljang Branch.

The Total amount of lost properties are estimated at Rs. 3,00,000/- (Rs. Three Lakhs only). The incidents could not be reported immediately due to insecurity of our lives and

volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.
