With due respect, I have the honour to state, on the 28<sup>th</sup> May 2023 at around 1:00 PM, unknown miscreants suspected to be from Meitei community have attacked at my Tailoring Shop "Nengcha Tailoring Shop", License No. SHADC - 3357 at Kangchup Chingkhong, Phaileijang Village, Kangpokpi District. The miscreants have break open the door and looted all the properties inside the shop.

The properties looted are as follow:

1. Tailor Machine Merit	8x12000	= Rs. 96,000/-
2. Tailor Machine Overlock	1x8000	= Rs. 8000/-
3. Electric Machine	1x17000	= Rs. 17,000/-
4. Button Stamp	1x3000	= Rs. 3000/-
5. Iron	1x1000	= Rs. 1000/-
6. Scissor	5pcsx800	= Rs. 4000/-
7. Clothes	Approx	= Rs. 1,00,000/-

The Total amount of looted properties are estimated at **Rs 2,29,000/-** (*Rupees Two Lakhstweny nine thousand only*). The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.


