Sir,

With due respect, I have honour to report that on 05/04/2024 at 04:30 Pm while I was performing my assigned duty i.e. as preventive measure of upcoming Lok Sabha Election 2024 District Police Thoubal, I was conducting regular checking at Waithou Special Naka Post under the supervision of Sr. SP/Thoubal. While conducting normal frisking and checking, a vehicle coming from Thoubal side towards Imphal was signaled to stop at the Naka point located at Waithou. However, the vehicle jumped the Naka suspiciously by speeding up and escaping from the Naka point towards Imphal side. Immediately, self and my team chased them and stopped the vehicle which is a Maruti 800 car (blue in colour) B/Regn. No. MN1X-0877. After the car was overpowered and stopped at Lilong Haorou Hangamthabi along NH - 102, the occupants came out of the vehicle and stood beside the road. They seemed to be under the influence of alcohol and they didn't wear any shirts. Then, the 5 of them started pulling and pushing with our team. I warned them to co-operate with a public official discharging official duty, but then they suddenly overpowered one of my men and grabbed my neck. Immediately, I warned them again but they restrained me from performing my duty, and thus, after final warning, I had to fire 5 blank rounds from service issue AK-45 Rifle to control them. I called for back-up on the radio set and some teams rushed to the area. After that, the unknown persons were detained for verification.

The persons and vehicle are handed over to your Police Station for verification and for necessary legal action.
