



Sub :- Filing of FIR against Armed Rioters

Sir,

1. Internal Security Duty columns of Assam Rifles were deployed in the general area of Kangchup for protection of civilians and maintaining peace in terms of the requisition by the Govt of Manipur. On 09 July 23 said columns were deployed on duty at Company Operating Base, Kangchup (COB Kangchup). Assam Rifles, villages of Makhom & Ponlen and Freedom Hill under the provision of Armed Forces Special Powers Act. At 2100hrs in the night on 09 July 23, unknown armed rioters started indiscriminate automatic fire towards COB Kangchup and the villages on the hills from the general area of Phaiyeng and Kadangband. On being fired upon by the armed rioters and under threat to own life and that of civilians in the area, Assam Rifles troops responded in a calibrated manner with controlled fire, in self-defense and for protection of civilians in the area. Firing was ceased by Assam Rifles troops immediately on cessation of firing by the armed rioters. The matter was also reported to SP Imphal West and ADGP (law and order), Manipur by the Assam Rifles.
2. The sustained deadly fire by the armed rioters with automatic weapons upon the security forces and civilians was in a trained and planned manner. The said fire continued till 2130hrs and thereafter intermittently/sporadically till 0245hrs on the morning of 10 July 23. No casualty of civilians was reported to Assam Rifles columns.
3. You are requested to kindly file an FIR against unknown armed rioters and investigate the incident for causing riots using deadly weapons, attempt to murder with deadly weapons, to deter public servants suppressing riots, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and unauthorized usage of fire arms and ammunition to include automatic weapons.


