I have the honour to inform that today is 5/4/24 at about 4 PM. my younger brother in law namely - Md Mustakin (39) s/o Md Akbar - Bahab of Lilong Usoiporpi Tharao. Lok was assaulted by the accused person by holding a Double - barrel gun at the noted P.O. and as a result of which my - younger brother Musta Kam received serious injury on his mouth and front teeth. The accused held on the mouth and teeth of my brother in law by holding the Barrel gun and threatened to the injured - Mustakin to be killed. My younger brother Mustakin is a Truck - Driver and he went at the P.O. for taking Stone from the nearby Stone Crusher and the accused committed crime for not giving <sup>tax</sup> illegal for taking and carrying <sup>stone</sup> from the stone crusher by the injured Mustakin.

That now my younger brother in law Mustakin (39) is now under treatment at "Noor Hospital" near Idang PS under treatment.
