The approximate value of looted & vandalized properties are estimated at Rs. 50,00,000 (Rs. Fifty Lakhs) approximately.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gamnon Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
