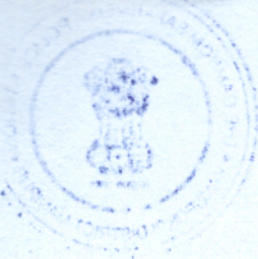

I along with my family members are taking shelter at Lamphel, IW by keeping my house under locked and Key. On 10/06/2023 it comes to light that, the Kuki arms militant had trespass my house and looted many valuable proiperties i.e furniture items, kitchen items, utensil items, clothing, electronics items, Gold (10 mohor) including a cash i.e a sum 15 lakhs by breaking the Lock and key which I had locked. The approximate value of looted & vandalized properties are estimated at Rs. 50,00,000 (Rs. Fifty Lakhs) approximately.

Regarding the matters I couldn't able to report to the concern Police Station i.e Gamnon Sapormeina PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.


