In that, the Kuki arms militant had trespass my official quarter and all household properties like furniture items, kitchen items, utensil items, clothing, electronic items and others were looted as well as vandalized my official quarter by the militant. The approximate value of burnt down/looted properties are estimated at Rs. 10,00000/- (Rupees Ten lakh) approximately.

Regarding the matters I couldn't able to report to the concern PS i.e Gamnom Sapormeina Police Station till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.


