

Sir,

With due respect, I have the honour to report that on 04-05-2023 at around 02:00 pm, unknown miscreants numbering about 500 persons from the Meitei community suspected to be Arambai Tengol, Meitei Leepun for Kangleipak Kanba Lup holding deadly weapons entered our village i.e. Kangchup Patjang and demolished/burnt down 25 houses along with household goods and properties including two -4(four) wheeler vehicles and robbed household materials, ornaments, etc and the domestic animals in the village. The approximately lost/destroyed is estimated to be about 10 crores approx.

The incident couldn't be reported in time due to insecurity of our lives and the volatile situation of the area.

I, therefore request you to take necessary action against the perpetrators/culprits involved in commission of the crime.
