Subject: Report on vandalism, looting of properties and burning down of house at Kangchup Songlung, PO-Lamsang & PS Sapormeina & District- Kangpokpi on 05-06-2023 at around 7:00 am.

Madam,

With due respect, I the undersigned would like to make a report to your good office about vandalism, looting of properties and burning down of house at Kangchup Songlung, PO-Lamsang & PS Sapormeina & District- Kangpokpi on 05-06-2023 at around 7:00 am by Meeitei/Meitei's goons suspected to be members of the Arambai Tengol and Meeitei Leepun along with a mob of Meeite/Meitei.

At the very outset, I would like to draw few line for your information that due to the present situation of ethnic class between Tribal and Valley based Meitei/Meeitei from 03/05/2023. That due to ethnic class the said members of the Arambai Tengol and Meeitei Leepun never stop vandalism, looting and burning down of tribal properties from their rented residence or from their resident in the valley areas till today. On 05/06/2023, at around 7:00 am in the morning my gate was destroyed Meeitei/Meitei's goons suspected to be members of Arambai Tengol and Meeitei Leepun and they vandalised, looted and burnt down my house, all my properties would worth Rs. 18,00,000/- (Rupees Eighteen lakh). On the said day, I along with other families members were attacked by the above mentioned members because we are Christian and I am tribal even my husband is a Meitei (I could still remember the words they shout at us stating that Meetei oirasu Christian ni, hat gedabani ...hatlo ...hatlo). We have to run for our life and I could not make the said report on time because I could reach my native place from Imphal as I am traveling one state to another to reach my native place.

It is requested to your good office to make entry of my report as Zero FIR and take action against the perpetrators and the members who shoot me as per Law and also issue me the copy of the said report for my reference in future.
