Today, i.e. 25th July, 2023 at 6:30 PM, received an information that, on the same day at around 6:15 PM, 2 (two) Buses Bearing Registration No. Viz. 1) MN04P-1476 2) B/Regn. No. MN05C 0086 driven by Unknown drivers suspected to be owned by Persons belonging to Meitei Community coming from Kangpokpi towards Imphal were forcibly stopped and were later torched by unruly mob numbering around 500-600 at Saparmeina Bazar on NH-2. However, no human casualties was reported in the incident and the two Bus were totally burnt down.

Hence a Suo-Motto case has been registered under FIR No 351(7)2023 G-SPM-PS U/S 153A/143/147/353/435/427/34 IPC for investigation.
