

I have the honour to report that my HYDRAULIC EXCAVATOR Machine bearing machine serial no. N635D00601, Year of Mfg. 2018, Engine No. 81A84445550, Invoice No. 17-18/00830, Model HYUNDAI R2151L which was purchased from one AFRICA PAYENG S/o Lt. Goyal Payeng, resident of Tezpur Balipara in the District Balipara in the District of Tezpur, Assam by executing an formalities was found set on fire while parked at Charbung Village, Kangpokpi District, P.S Saparmeina by large numbers of unidentified KUKI militants on 04/05/2023 at about 4:45 pm. After the mob violent the said machine was badly damaged. The approximate value of the said machine is Rs. 32,00,000/- (rupees thirty two lakhs) only.

I could not report in time due to present law and order situation.

It is, therefore, requested to you kindly take up necessary legal action against the above culprits.


