As a result 4 (four) person got sustained injury on their person and 3 (three)persons were succumbed due to bullet injuries on the spot. Receiving the information combined team of state force and CAPF who were deployed at the kangchup area rushed to the area to rescue the injury persons and deceasedpersons.
