Today, i.e. 3/7/2023 at 10:20 AM received an information from own source that two Buses Bearing Registration No. Viz. 1) MN04P-1476 2) B/Regn. No. MN05C 0086 which were burnt down by the unruly mob on 25/7/2023 at around 6:15 PM at Saparmeina Bazar along NH-2 and in which a Suo-Motto case was registered under FIR No 351(7)2023 G-SPM-PS U/S 153A/143/147/353/435/427/34 IPC for investigation were found stolen on the intervening midnight of 1/8/2023 & 2/8/2023 by unknown miscreants from the place where the two buses were kept. It is worth to be mentioned that the two exhibits (Burnt Down Buses) could not be towed and kept at Safe Custody due to the unavailability of towing machine and also due to the present Law and Order Situation of the area that the unruly mob resist and opposed the Police Personnel to take the two burnt down buses in Police Custody on the night of 25/7/2023. Thus the two burnt down buses were kept on the roadside of NH-2 at Saparmeina Bazar.

Hence a Suo Motto case has been registered under FIR NO.364(8)2023 G-SPM-PS U/S 143/147/353/201/379/425/34 IPC for investigation.
