Today i.e. 14-05-2023 at 8:30 am, received a reliable information that some Tata Tippers which are on their way towards Imphal were stopped by large mob at Saparmeina bazar, immediately self along with 2(two) teams of Police rushed to the said location and found 5(five) Tata Tippers stopped by the mob however they were retrieved and provided security escort towards Imphal. While on our way escorting the vehicles towards Imphal, a large mob numbering about 300/400 again stopped/blocked the road by piling up boulders near G.Kholep along NH-2 at about 9:20 am and the mob tried to burn the vehicles. As a result, a scuffle broke out between the Police and the mob, the mob turns more and more violent and in order to control the unruly mob, police personnel fired several rounds of ammunitions in the air however they outnumbered/overpowered the police personnel and burnt down 2(two) Tata tippers-(1) bearing regn. no. MN05C-3920 and (2) Tata Tipper bearing regn. no. not known. The other 3(three) Tata Tippers were hardly rescued/retrieved from the unruly mob and managed to escort safely till Gamgiphai village.

Hence, a suo-moto case under FIR No. 36(5)2023 G.SPM PS U/S 147/431/353/435-IPC for investigation.
