




Today i.e 28/05/2023 at 4:10 pm receive reliable information that on the same day at @ 04:00 pm some Kuki militants and the villagers of the adjoining area of PhayengChingKhunou and Kangchup opened fired from the morning. On receiving the information a combine police persohnel under the supervision of SP/IW Dr. S. Ibomcha Singh (MPS) and OC, CDO/IW, DYSP Rk. Eden Singh (MPS) and CAPF deployed at the adjoining area of Phayeng and KangchupChingkhong rushed to the firing area i.e K. Songlung to control the continuous firing between the Kuki militants and the villagers. While the CDO/IW Bullet 4 led by SI Kh. Bonny Singh and Special CDO team led by Sub. Vivek Singh rushed at the K. Songlung to prevent the untoward incident out of communal violence that occurred from 03/05/2023 till date between the kuki and Meitei. On the way at K. Songlung some suspected to be Kuki Militants which were already station at the K. Songlung area ambushed to the CDO teams. As a result one SI of CDO/IW namely SI Kh. Bonny Singh of CDO/IW got bullet injury on his right hand and Rfl No. 1710070 Ng Sony Singh of 7 IRB attach to CDO/IW got bullet injury on his left chest and the vehicle of CDO/IW (Bullet 4) was damage by the open fired of the bullet by using verily sophisticated weapon by the Kuki millitants.

Hence a Suo Motto Case is register under FIR No. 535(5) 2023 LSG-PS U/s 326/427 /307/5061PC 25(1-B) Arms Act & 16 UA(P) Act for investigation.


