Dear Sir/Madam.

With reference to the above cited subject. I have the honour to report to you as follows:

- That, I am a scheduled tribe belonging to the Thodou-Kuki, which is a recognized tribe under the constitution of India. And. I am a permanent resident of Kangchup(HinnomVeng) Village P.O- Lamsang, P.S Gamnom Sapormeina, District-Kangpokpi, Manipur.
- That, on the 28th of May, 2023 at about 11:00 AM/PM, a huge contingent of armed radical Meitei/Meeteis suspected to be members of the Arambai Tenngol and Meitei Leepunheaded by the Manipur State forces like the Manipur Police Commando and the Indian Reserved Battalion (IRB) attacked our viilage and in the process, they have looted, Vandalised and torched my house.
- That it may be reported here that the miscreants were shouting slogans like "KANGLEIPAK YAIPHERE", "KUKI HATLO" "KUKI HATLO", etc. While they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur state Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that no harm could be done to them.
- That at the time of the attack we somehow managed to escape to save our live ur der the compelling circumstances and thus could not take our belonging including important documents like pension card, Aadhar card, ATM Card, PAN Card, educational certificate, etc apart from other tangible materials. A list of our properties looted/destroyed/burnt is attached here under with its estimated costs. The total loss suffered is estimated to be about Rs. 20,00,000/-(Rupees twenty Lakhs) only.
- That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I am settled at S. Tuoljang Village And thus I am filing the report lately today.

In the given circumstances, I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
