This report is treated as an OE of the case under zero FIR No.0(6) 2023 LSG-PS u/S 153A/147/148/149/447/427/436 IPC & 25(1-C) A.Act. Sd/-OC/LSG-PS

Sir,

I would like to state that few words to you regarding the lost, destruction and burning of properties in KangchupChiru Village. The current ethnic violence conflict between Meitei and Kuki brought a great loss of livestock and properties damage in the village. On 2nd June 2023, gunfight broke out in Kangchup at arounf 10:00 am till 6:30 pm. Some 2/3 houses were destructed and burned down by some unknown miscreants during the gunfight. Many roof and wall of living houses were pierced by bullets and many villager's livestock were also lost. As all villagers were stranded and hiding together inside some houses during the gunfight, there is no witness on whose side destructed and burn down the houses.

Here are the lost and destructed properties along with photograph.

- 1. NR Nison-eng's cowshed burned and cattle lost (approximate cost 1.5 lakhs).
- 2. MS Athar's houses burned (approximate cost 3 lakhs)
- 3. MS Chongmulen's houses destructed (approximate cost 60,000,-)
- 4. The approximate cost of all livestock lost during the conflict is 1 lakhs.

If you kindly hear villagers losses and take a proper action under the law and the matter couldn't be put up and reported on time due to prevailing low and order issue out of the communal violence conflict between the two communities.

I would be very grateful to you.
