Today i.e. 20/06/2023 at 8:16 pm receive reliable information that on the same day at about 8:12 pm 5/6 rounds of sophisticated assault rifle were fired towards security bunker on the western side of Singda Bazar (just on the border with Imphal West towards Kangpokpi District) from the hill side Jungle of Singda Kuki Villages by some unknown Kuki Miscreants/Militants and immediately retaliated by 7 MR and 16 Bn BSF personnel deployed at the area to flux out the Kuki Miscreants/Militants and some search light were also fired from the side of nearby 22 AR Kangchup Post and still alert. No casualty was found during the incident.

Hence a Suo-motto case has been registered under FIRNo. (0)551(6)2023 LSG-PS U/S 147/153A/307/506/34 IPC & 25 (1-B) A Arms Act & 16 UA(P)Act for investigation.
