



Sub: F.I.R. against Mr. Seitinpao; aged about 54 years, resident of Kangchup Geljang Village for alleged threat intimation and carrying out the threat and injuring Aheibam Rishikesh; aged about 31 years, S/O: (L) Aheibam Brajabidhu of SingdaKadangband Part-1 Village on the intervening night of 23/05/23 and 24/05/23 at around 01:25 a.m.

Sir,

As mentioned above in the subject matter, one Mr. Seitinpao; resident of Kangchup Geljang Village made 3 (three) missed call to Kshetrimayum Nabakumar Singh; aged- 41 years; S/O (L) Kshetrimayum Dhane Singh, the Ward Member of SingdaKadangband Part-1 Village at 05:35 p.m. on 23/05/2023.

Kshetrimayum Nabakumar Singh at the moment was having his evening meal. Mr. Seitinpao made a fourth call which was answered by Ksh. Nabakumar Singh. On answering the call Mr. Seitinpao threatened to attack SingdaKadangband Part-1 with 40 (forty) numbers of AK-47 assault rifles that evening without telling the exact time and place of attack.

At the very moment of Mr. Seitinpao's threat call the respected IG of Police was on his visit to SingdaKadangband Part-1 to take stock of the current Law and Order situation in the area. As Ksh. Nabakumar received the threat call he gave the phone to Respected Sir IG who then warned Mr. Seitinpao to book under befitting law for threatening and disrupting peace.

At 01:25 a.m (dt: 24/05/2023) Mr. Seitinpao accompanied by around 6 (six) Kuki Militants in Olive Green uniform attacked a Sentry post set up by the Voluntary Civilian Vigilante group of SingdaKadangband Part-1, located on the North-West side of the village at I.F.C.D Quarter. During the attack one Aheibam Rishikesh ; aged about 31 years, S/O: (L) Aheibam Brajabidhu of SingdaKadangband Part-1 Village sustained bullet injury on the upper right thigh and right palm.A.

Rishikesh suffered two punctured wounds on the upper right thigh and his right little finger barely hang by a ligament. I am enclosing a photo copy of the wound sustained by the victim as proof.

In this connection, I would like you to book Mr. Seitinpao as a member of the Kuki Militant. I firmly believe that you would be kind enough to take up necessary legal action against Mr. Seitinpao in this connection.
