

Subject: Report of Death due to communal Violence in Manipur.

Sir,

With due respect, I would like to state that (L) Laishram Budha Singh(58) S/O (L) Laishram Ibochou Singh of Khangabok part-III, Lamlong Khunou Leikai was the only bread earner in his family. He had been running his own tailor named Raju Tailor at Motbung Charhajar Kangpokpi District, Manipur on rent room belonging to Kamal Kumar Paorel.

That, on 05<sup>th</sup> May 2023, a communal riot occurred there in the evening. He injured in the riot. He ran into the nearby Assam Rifles camp to save his life from the attacked. As his health condition became worse. He was taken to Sekmai Community Hall(Relief Camp), Sekmai by the Assam Rifles. After his family being informed of his condition and arriving there he was taken to RIMS and admitted there and was under treatment. But suddenly on 7<sup>th</sup> May 2023 the concerned doctor declared that the patient succumbed to his injuries at 6:32 PM.

Due to the communal Violence in the state our rented Accommodation came under by the kuki Mob and gun tolling kuki terrorists. Mu husband who was the only bread earner of the family, succumbed to the violence unleashed by the kuki mob and terrorist. Our property worth about ₹ 8,00,000/-(Eight Lakh only) was vandalized and looted by the kuki mob.

I, therefore request you to register an FIR investigate the case and kindly make it possible for the bereaved family to get financial assistance from the government.
