

With due respect, I have the honour to report the following few lines that, I along with my family members were staying one rented house run by Leimakhong Hill Town located at Leimakhong Bazar Kangpokpi District since last 10 years back. Also running a chicken and fish shop at the said rented house. However, on 29th May, 2023 at around 3:30 pm, some unknown miscreants were torch many houses and looted many valuable properties at Leimakhong Bazar, Kangpokpi District, In that, all the properties belonging to me of Shop items were looted and burned down by the unknown miscreants. The approximate value of properties are estimated at Rs. 85,000/-. (Eighty five thousand) only approximately.

Regarding the matters I couldn't able to report to the concern Police Station i.e. Gamnom Sapermeina PS till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is, therefore, requested you to kindly take up necessary legal action against themiscreants involved in the commission of the crime.
