



1. House - 700000/-
2. Furniture items - Rs. 62,000/-
3. Electronic items - Rs. 40000/-
4. Clothing & house items - Rs. 1,10,000/-
5. Kitchen items - Rs. 50,000/-


Total approximate value is about Rs. 9,62,000/-approximately.
