



With due respect, I have the honour to report that on 03/05/2023 at around 11:20 pm, some kukis militant numbering about 90/100 with sophisticated armed, knives, iron rod, and weapon sharp object have come and burn down my house and looted many valuable properties from my house located at Charhajare Meitei Leikai near Namthang Football ground.

The properties that were burn down/looted are as follows:

1. House - 700000/-
2. Furniture items - Rs. 60,000/-
3. Electronic items - Rs. 42000/-
4. Clothing & house items - Rs. 1,00,000/-
5. Kitchen items - Rs. 50,000/-

Total approximate value is about Rs. 9,52,000/-approximately.

Regarding the matters I couldn't able to report timely to the concerned police station i.e G-Saparmoina Police Station due to the present situation in the state.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest


