

Today i.e 10/06/2023 at 2:40 pm receive a reliable information that on the same day at about 2:30 pm while conducting area domination, patrolling&checking by the combine team of C-45 BSF led by Assistant commandant Belavalekar Vinayak Pandurang, Inspt. Anilchandra Mutumand SI Th. Samarjit Singh of CDO Lamsang led by Dysp. Ops./Rk. Eden Singh (MPS) from Kangchup Chingkhong to K. Songlung village giving information to OC/ Kangchup PS, recovered two nos. of improvised country made pipeguns from 2 (two) bunkers on the northern side of K. Songlung Village which were used by the Kuki militants and the same articles were seized at 3;50 pm form the spot of the same day by observing formality. And also dismantled 4(four) bunkers.
