This is to inform you that on the evening of 3rd May 2023, Wednesday, at around 9:30 pm, some of the agitating mob burnt and looted all the shipments that were inside the carting truck with registration number MN01 9970. The mob also damaged the windshield and the two side glasses of the vehicle. The truck was carrying the RT shipments from three DCs of Delhivery Limited viz, Tadubi _ Dohu Colony D,Senapati _Old Market _D and Senapati _Kangpokpi _D towards Imphal_Takyel _I. The incident took place at Saparmeina along NH-2, about 500 m from the police station. The number of the shipments that were burnt and was looted was 204.

The incident could not be reported on time due to incomplete data of the shipments as there was no internet connection.
