

Sir,

With due respect and humble submission, I beg to state that on 4/05/2023 at around 12:00 PM some unknown miscreants armed youth suspected to be People liberation army (PLA) united national liberation front (UNLF) Kanglei Yaowon Kanna Lup (KYKL) and prepakcadres assisted by meeitei Youth organization Arambat Tenggol meeitei leepun and kangleipakkanbalup (KKL) numbering about 1000 member carrying sophisticated like AK Rifles, SLR forcefully entered my village Kangchup Patjang village, P.O. Lamshang, P.S. Gamnom Sapormeina, SaituGamphazol Sub-Division, K. Geljang, Kangpokpi District, Manipur. After looting all the valuable house hold items and properties my house, garage, my four wheeler alto 800, Reg. No. MN01G8722, Chassis No.MA3EAA61501849564, Engine motor No. F8DN4617904, 100 bags of rice grain with house was burnt down to ashes living homeless apart from that some important parts of my house i.e kitchen sheed with utensil Almera (6) sofaset (2), computer (2) refrigerator (1) MI-TV 53 cm, washing machine, inverter, gold neckless, blanket (30) metress (10), gas stove (5) cylinder (5) dining table 2 set, chair (10) sintex (5) motor big size (2) , some utensils and all the important documents were totally burnt down.

The approximate value of lost properties is estimated at about rupees 80 lakhs.

I could not report the matter in time due to the prevailing law and order situation.

It is therefore, I requested to kindly register the case and take necessary action according to law.
