Sir,

I have the honour to report you that on the intervening ment of 3/5/2023 and 3, the large numbers of kukis with hairs and 4/5/2023, the large numbers of kukis with knives, sticks, iron rods, weapons, sharp objects etc., broke into my house and completely burn down as well as destroyed my two houses and properties using fire and weapons, also looted much of my properties, located at Charhajare, near Sanatan Sanskrit Vidyalaya. The properties that were burn down and looted are:

I made this report to your good - office ,as present prevelling situation, it is not accesible to my jurisdiction to report the same at P.S.-Sapormeina Saitu Gamphazol Kangpokpi District .I also can't make this report in time, because I and my family were not in condition to report the unfortunate incident. On the day of the incident happened i.e., on intervenning night of 3/05/2023 and 4/05/2023, the Motbung Assam Rifle , personnel rescued us and give shelter in their camp till 5/05/2023, and finally shifted us to Sekmai Police Station in evening of the same day. Thereafter, we were taken to relief camp and handover us to our relatives and we are presently sheltering at relatives residence. The situation was so harsh, that the emotional distress of losing mentire properties and leaving my birth place was so painful .New face of difficulties to manange the settlement of my family and children were really tough and not manageable. Therfore, I could't make the report in time.

I therefore, request to your good self to take up necessary legal action against the large numbers of Kukis who burn down my house and looted my properties.
