Leepun and Arangbam Tenggol

Sir,

I, have the honour to state that, on 4th May, 2023 at around 11:30 AM some Meitei miscreants belonging to Meitei Leepun and Arangbam Tenggol who had been carrying sophisticated weapons like AK rifles, 303 rifles, Pistol, Motor etc, with vehicles forcefully entered in my village located at KanchupChingkhong, Kangpokpi District. They looted all valuables and set ablaze to ashes. The approximate value of lost and destroyed are to be about Rs.3,00,00,000/ (Rupees three crore) only.

I, therefore request to kindly registered a regular case and take necessary legal action according to Law. I am herewith enclosed the lists of Assets Lost.
